


## **Certificate of insurance**



### Procedure in case of loss and/or damage

For the assessment of the loss and/or damage, the interested party shall as soon as possible apply to the surveyor and/or average agent(s) mentioned in the policy or, should no surveyor and/or average agent(s) be mentioned, to the nearest Lloyd's agent or another agent of good repute. The surveyor and/or average agent(s) being appointed for survey only. Moreover, he shall immediately hold liable in writing the shipping company and/or carrier and/or their agents and/or the bailee and/or any other third party who may be liable for loss and/or damage to the goods and invite them to attend the survey; no receipt may be issued without immediate notice being given in writing of the remarks concerning damage noticed or suspected. In order to ensure the speedy settlement of the claim the interested party shall, when making the claim, submit available documents, as mentioned hereinafter:

- 1. Original policy or certificate of insurance;
- 2. Original invoice, specification and/or weight notes;
- 3. Original bill of lading and/or other consignment note;
- 4. Survey report of any other document proving the extent and cause of the damage;
- 5. Landing and weight receipts;
- 6. Correspondence with the shipping company and/or carrier and/or their agents showing that (any of) these parties have been held liable for the damage.

### **Claim period**

A claim can be submitted in MyBolster up to 30 days after final delivery.

#### Important note

It is in all cases the duty of the assured and their agents to take such measures as may be reasonable for the purpose of averting or minimizing a loss and to ensure that all rights against Carriers, Bailees or other parties are properly preserved and exercised.
